

## **Dance World Academy (DWA) 2024-2025 Permission to Participate in Dance**

### **Please check on the registration form that you have read and agree to the policies below.**

As the parent or child's legal guardian, I understand the nature of dance training and believe my child to be qualified to participate in dance class.

As with any physical activity in a public place, I further understand that there is a risk of exposure to injury (despite best practices) and/or infectious diseases (despite best practices) for myself and my child, as a participant, spectator at events, during classes or due to our presence at this facility.

I understand that if Dance World Academy needs to be temporarily closed due to quarantine, deep cleaning or a government mandate, classes will continue using the Zoom platform. Tuition policies will continue to be in effect during that time. There will be no Zoom classes during weather closings.

I give permission for images of my child, captured during regular and special dance school activities through video, photo and digital camera to be used solely for the purposes of Dance World Academy promotional material (such as advertising, our web site and social media) and waive any right to compensation or ownership.

For Preschool and Combo 1 Students: I give permission for a female teacher, teaching assistant or female staff member to help my child if necessary after he/she goes to the bathroom or help change my child into clean clothes in case my child has an accident related to not making it to the bathroom on time. Please put an extra set of clothes in their bag.

I understand that as a reward for my child's hard work, all dance students will receive one achievement trophy at the end of the year regardless of the number of classes per week that they enroll in.

I understand that attendance every week is expected in class in order to make progress. As a courtesy to our faculty, I will call the school if my child is going to be absent.

I understand that only one parent should accompany my child to class if necessary to avoid overcrowding in the studio waiting areas. I understand that drop off and pick up is preferred if possible. Gum chewing, eating, drinking (except water) and smoking is not permitted in the studio or waiting areas. I further understand that students and parents are to behave respectfully at all times to teachers, staff members, other parents and other students.

In the event of snow, I will check the web site or social media to see if classes are being held that day. I understand that classes missed due to snow closings may be made up but it is not mandatory to do so. I understand that there are no tuition reductions for snow closings.

I understand that for safety reasons, students are not permitted to wait outside of the studio buildings for any reason. Students are also not permitted to visit the stores in the vicinity without my giving permission to the teacher. I will pick up children promptly from class.

I understand that my child should come to class with a water bottle, hand sanitizer and a yoga mat and bring all of his/her belongings inside of the classroom with him/her. I understand that Dance World Academy is not responsible for money or any personal belongings (including ipads and phones) that are lost or stolen.

I understand that parents are kept informed of the school's activities by notices given out in class and posted on the web site and social media (Facebook and Instagram). The best way to keep informed is to ask my child if they received any notices after each class and also to check their dance bag. We also email important information and reminders so please check your email.

I understand that I will not send my child to class if they are sick, have a fever or show any symptoms of Covid-19.
